Plan for event with Townsend Land Trust

Veronica Kell described her idea for a family trail walk involving the boy scouts, girl scouts, Townsend Historical Society, Squannacook Greenways, and the Townsend Land Trust. The hike will highlight some of the available properties in Townsend for walking, including the Meeting House Park.

The tentative date will be New Years Day.

We may need a car shuttle for the Rt. 119 crossing between Greely Road and Meetinghouse Road. We could also shuttle people from the parking lot in the center of town to the cul-de-sac on Old Meetinghouse Road.

We will ask the scouts to have refreshments at Harbor Church and/or at Old Meeting House Road.

Veronica will discuss the idea with the Land Trust, Historical Society, and scouts.

Plan for fall trail walk with Wild & Scenic River

Al Futterman and Bill Wilkinson of the Wild & Scenic River study committee are interested in working with us on a trail walk. We will meet at Bertozzi and bring people out to the river there.

Joan will contact Al and Bill to schedule for Sunday, November 12th (rain or shine). Bill will post a video on our Facebook page to advertise the walk as an opportunity to learn about Wild & Scenic River and walk the rail trail. Joan will ask Al to include the event in the NRWA newsletter. Joan, Steve, Bill, Pete Carson, and Don Klein agreed to help out.

Update on property appraisal and acquisition

Joan met with Jim Czupryna, a Massachusetts certified appraiser, and obtained a written quote of \$2,300 for consulting on the 1.3 acre parcel. The appraisal will meet requirements for a DCR grant application.

We decided to get a standard appraisal first. A vote to authorize up to \$600 for a standard appraisal was seconded and passed unanimously.

Status of environmental permit application

Harbor Village has given written permission for construction access and Historical Society has given us a draft easement. These should be suitable for our draft application, but may not be adequate for the final.

Mark will add Meeting House Road to the map as a fall-back access point.

Bill and Steve will address the group at their annual meeting on Wednesday, November 15, 6:00-8:00.

Fundraising and financial report

Four businesses gave donations in response to a letter Bill sent. Our total assets are currently at \$116K.
