At the moment the rail bed of our planned rail trail is owned by the Massachusetts Bay Transit Authority (MBTA). The MBTA is willing to lease the rail bed to the municipalities of Townsend and Groton, but both towns are hesitant to proceed because of fears of cost and environmental liability. Both towns formed official town committees to study the issue, and both committees came to the same conclusion - that the best way to build and maintain this rail trail is by following the Wachusett Greenways model. Wachusett Greenways is another non-profit in Massachusetts that has build large sections of the Mass Central Rail Trail. The cost of their stone dust rail trail has typically been about 1/10 of the cost of a state-built trail. They also have a well established tradition of using volunteer efforts to maintain their rail trail. In fiscal year 2011 we incorporated our non-profit Squannacook Greenways in order to build the Squannacook River Rail Trail according to the vision described above. During 2011 we began negotiations with the Massachusetts Department of Conservation and Recreation (DCR) to sign the MBTA lease, and then sign a memorandum of agreement with us, giving Squannacook Greenways sole responsibility for the construction and maintenance of this rail trail. At the end of fiscal year 2011 we were requested by DCR to submit a formal written proposal, which was in progress on Dec. 31, 2011.
